REQUEST FOR EXTENSION TO CLARIFICATION OF FURTHER INFORMATION RESPONSE PERIOD

On behalf of the applicant, **Blackwin Limited**, we hereby <u>request a time extension</u> from South Dublin Dublin City Council to respond to the request for Clarification of Further Information (CFI), dated the 10<sup>th</sup> of October 2022, which followed from a Further Information request issued on the 31<sup>st</sup> of May 2022, in respect of the above-mentioned development, as provided for under Article 33 (3) of the Planning and Development Regulations 2001 (as amended).

The 6 month period from the date of the FI request for the proposed development would have been scheduled to expire on the 30<sup>th</sup> of November 2022.

As provided for under Article 33(3), we wish to request a 3 month extension of the period for responding to the CFI request. Article 33(3) of the Planning and Development Regulations 2001, as amended, reads as follows:

"(3) Subject to sub-article (3A), where a requirement under sub-article (1) or sub-article (2) is not complied with within the period of 6 months from the date of the request for further information under sub-article (1), or such additional period, not exceeding 3 months, as may be agreed by the planning authority, the planning application shall be declared to be withdrawn and the planning authority shall, as soon as may be, notify the applicant that the application has been declared to be withdrawn and enter an indication that the application has been declared to be withdrawn into the register." (Emphasis Added)

A 3 month extension of time to respond to the FI request will extend the period for submitting the CFI response until the  $9^{th}$  of March 2023 (including the 9 days for Christmas as provided for under Section 251 of the Act).
