Electric Vehicle car parking spaces to include 3 no. disabled EV spaces, 5 no. additional designated parent and child spaces, 2 no. covered click and collect parking spaces with a canopy (approx. 33sqm). A total of 92 no. car parking spaces will be provided overall, together with ancillary generator (approx. 7sqm) within the surrounding compound (approx. 23sqm) along with all site development works.


