We wish to make the following observations with regard to the above referenced Retention Application

- 1. The scale of the building to the rear of the garden is overbearing, having regard to the adjacent properties
- 2. The roof in particular appears to be of a more significant pitch and height then is show on the drawings and this now significantly blocking the available sunlight in the adjoining properties, in particular the rear garden of number 7 Aranleigh Gardens (to the N/E) This impact could have been mitigated by the use of a flat roof
- 3. The building also appears to be elevated above the ground which exacerbates its overbearing presentation. This could also have been avoided
- 4. There are windows on each side of the building at the property boundaries which overlook the adjoining gardens in particular those at numbers 3 and 7 Aranleigh Gardens
- 5. The proposed use could have been accommodated in a smaller building within the area permitted as Exempted Development
- 6. Noting that the building is fully serviced with power and plumbing, there is a significant risk given the scale and layout of the building that it will be used for residential occupation now or in the future
- 7. Granting Planning Permission, via Retention, for such developments, after they are constructed, will set an undesirable precedent for future similar developments in the area
