Bills' Hamlin critical after cardiac arrest

NFL safety collapsed during game

DAMAR HAMLIN remains in critical condition in hospital after the Buffalo Bills safety suffered a cardiac arrest during Monday's NFL game against the Cincinnati Bengals.

Hamlin received CPR on the field after colliding with Bengals wide receiver Tee Higgins.

'Damar Hamlin spent the

night in the intensive care unit and remains in critical condition at the University of Cincinnati Medical Center,' the Bills posted on their official Twitter account.

Bills players and staff were seen praying together on the field as an ambulance took 24-year-old Hamlin to hospital.

Hamlin's team-mates were given a standing ovation by fans and NFL commissioner

Roger Goodell soon announced that the game had been postponed following the incident.

An NFL update confirmed the fixture will not be finished this week but added the Bills' clash against New England Patriots on Sunday is still scheduled to go ahead.

A statement said: 'After speaking with both teams and NFLPA (NFL Players Association) leadership, NFL Commissioner Roger Goodell informed the clubs

today that the Bills-Bengals game will not be resumed this week.

'The NFL has made no decision regarding the possible resumption of the game at a later date.'

There was an outpouring of emotion across the US in response to the incident, with fans gathering outside the University of Cincinnati Medical Center to hold candlelit vigils for Hamlin.

His family said they were 'deeply moved' by the displays of affection.
