On behalf of my client Elis Ni Chinnseamhain I hereby apply for planning permission for Conversion of her attic storage including changing her existing hipped end roof at a gable end roof, a dormer window to the rear, 3 velux rooflights to the front and a window to the new gable wall, all at roof level to No 34 Crannagh Park, Rathfarnham, Dublin 14

Elis wishes to alter the profile of the end of her house to allow a fully compliant access stairs to her attic storage space and to add a rear dormer window and velux footlights to enhance this storage space.

SITE LOCATION AND DESCRIPTION

Crannagh Park is part of the Crannagh Estate which is a mature estate characterised by large semi detached residences with large gardens; my clients house is located towards the middle of the estate.

While there have not been any gable conversions applied for within Crannage Park, there are a number of varying roof profiles withing the local area, as shown below:-
