We are very concerned that we are going to loose our security/privacy on the North border of our course due to Planning Reference SDZ23A/0004 - Clear Real Estate Holdings Limited. We would be asking for your support in ensuring that the hedging (on the north border of our course) remains in place going forward and that a two and a half metre high concrete wall with netting on top be built by Clear Real Estate Holdings Limited to ensure the security of our course and the security of future residents (from errant golf balls) in the proposed planning application by Clear Real Estate Holdings Limited.
