Dear Mr. Brohan,

As the attached Glint and Glare report finds that any impact to Military aviation is unlikely. Following consultations with our colleagues in the Irish Air Corps, the Department of Defence accepts the findings of the report.

In the event of future impacts from PV panels, the owner should mitigate the impacts as soon as possible.

While impact from cranes appears unlikely, The Department will need to know the height of cranes to be used before we make such a statement.

I have attached the crane proforma for the developer. This form must be returned to "MDL_AirspaceManagementCell" airspaceandobstacles@defenceforces.ie allowing 28 days notice prior to the use of cranes.

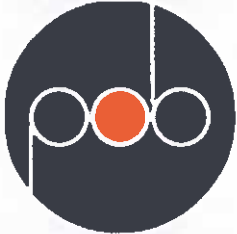
