I refer to your submission received on 21-Feb-2023 to comply with Condition No 5 of Grant of Permission No. SD22B/0291, in connection with the above.

In this regard I wish to inform you that the submission received is deemed partially compliant.

Comments:

1. Condition 5 states:

Sustainable Urban Drainage Systems (SuDS) and Landscaping The applicant has not proposed any SuDS (Sustainable Drainage Systems) features. Prior to the

commencement of development, the applicant shall submit the following:

**Application Type:** Compliance with Conditions

a) a drawing in plan and cross-sectional views clearly showing proposed Sustainable Drainage Systems (SuDS) features for the development, for the written agreement of the Planning Authority. The applicant shall include SuDS (Sustainable urban Drainage Systems) features for the proposed development such as but not limited to the following: Rain Gardens, Planter boxes with overflow connection to the public surface water sewer.

- Permeable Paving
- Grasscrete
- Green Roofs
- Rain gardens

- Planter Boxes
- Water Butts
- Other such SuDS
- b) A summary, in a digital format, quantifying and detailing the following:
- tree and hedgerow removal;
- tree and hedgerow retention;
  - new tree and hedgerow planting.

The applicant should reference the SDCC Sustainable Drainage Explanatory Design & Evaluation Guide prior to submission.

## Assessment of Compliance Submission for Compliance with Condition:

The applicant has submitted two drawings tiled *Drainage Layout & Details (drawing ref 5942/C101) and Drainage Details (drawing ref 5942/C201)* dated January 2023.

The applicant has presented SuDS details in the drawings with the:

- (a) private permeable paving.
- (b) inlets from roof drainage
- (c) hydro planter installation 5 module build out option.
- (d) hydro pave detail
- (e) bio retention system rain garden
- (f) Paved area gully connection details

However, the applicant has not submitted details of the following:

A summary, in a digital format, quantifying and detailing the following:

- tree and hedgerow removal;
- tree and hedgerow retention;
- new tree and hedgerow planting.

## Assessment of Compliance Submission for Compliance with Condition:

The Planning Dept considers that the submitted drawing tiled *Drainage Layout & Details (drawing ref 5942/C101) and Drainage Details (drawing ref 5942/C201)* dated January 2023 satisfies the SUDs requirements of condition 5 part (a).

However, the Planning Dept considers the documentation submitted inadequate to the complete requirements of condition 5 part (b) and therefore is deemed partially compliant.



## **Recommendation:**

Therefore, I recommend that the applicant be notified that Condition 5 of SD22B/0291 has only been partially complied with Condition C5(a) and not (b). "
