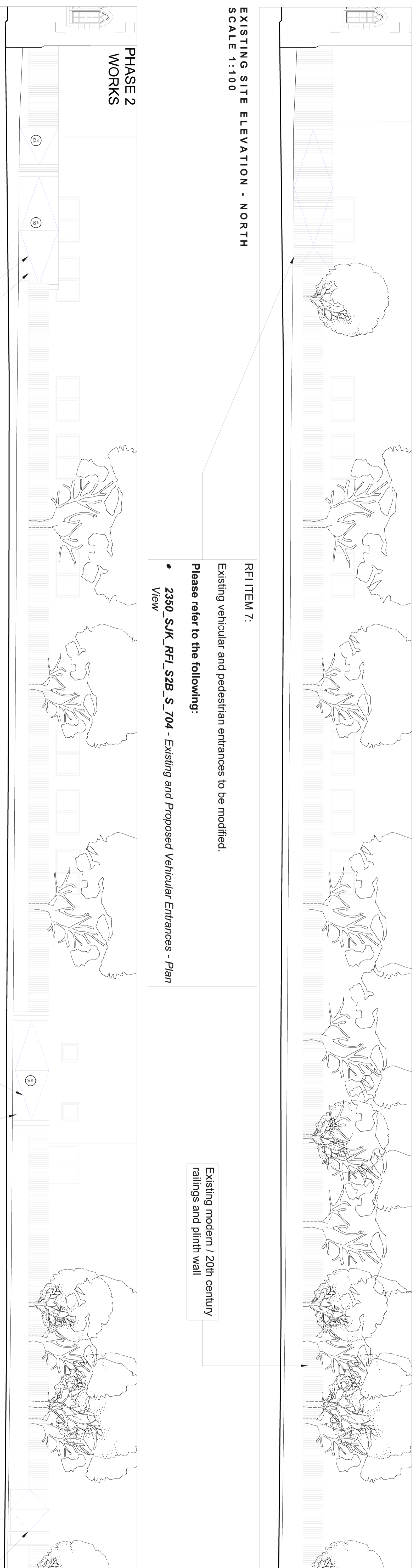


EXISTING SITE ELEVATION - NORTH

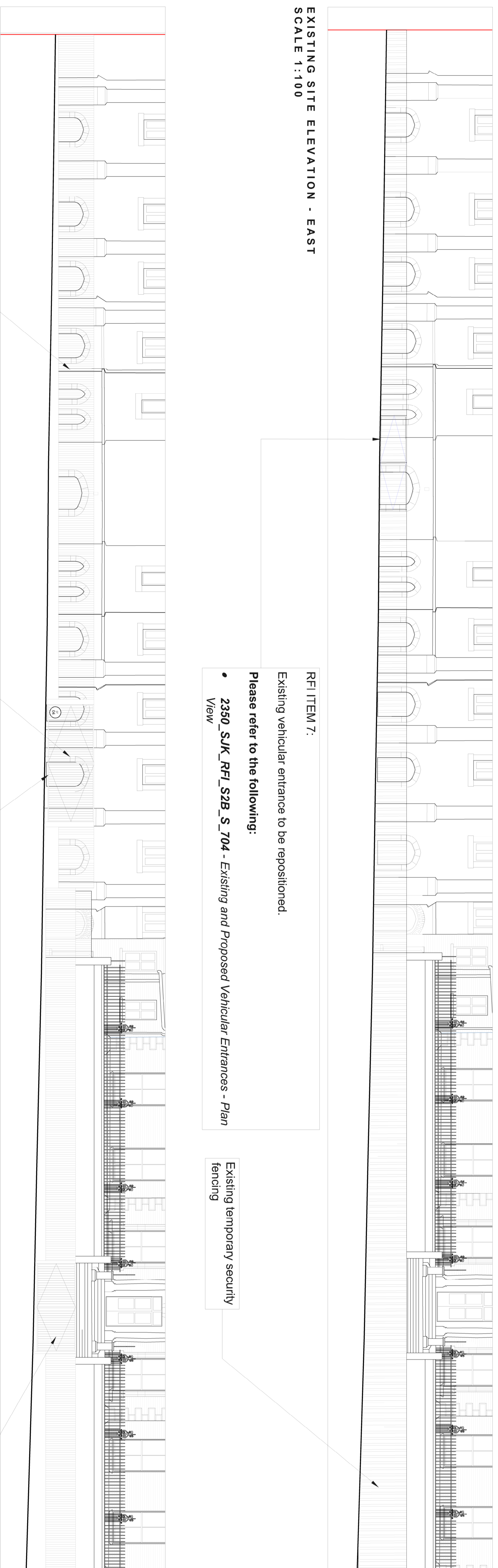

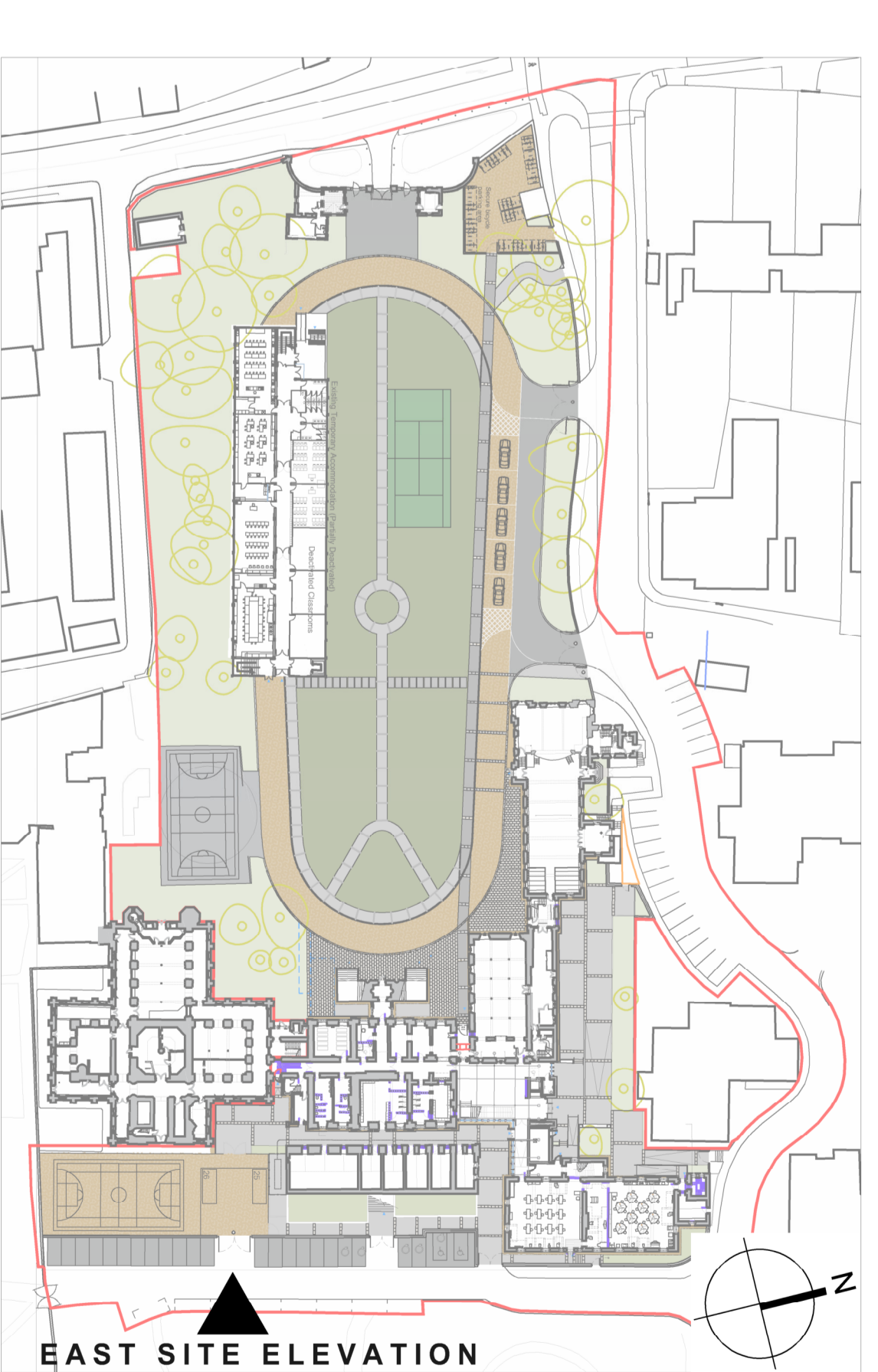

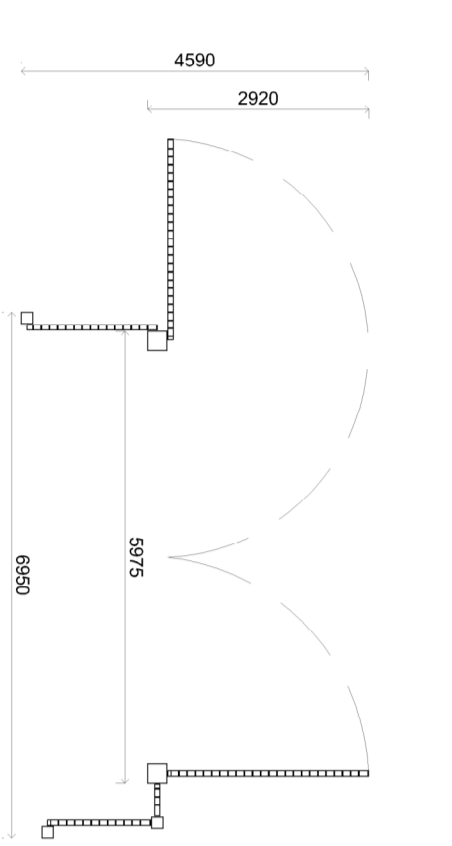

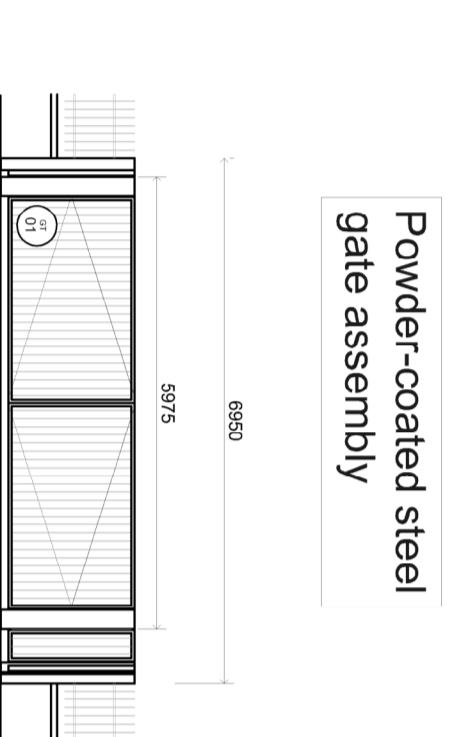
KEY PLAN - PROPOSED SITE LAYOUT

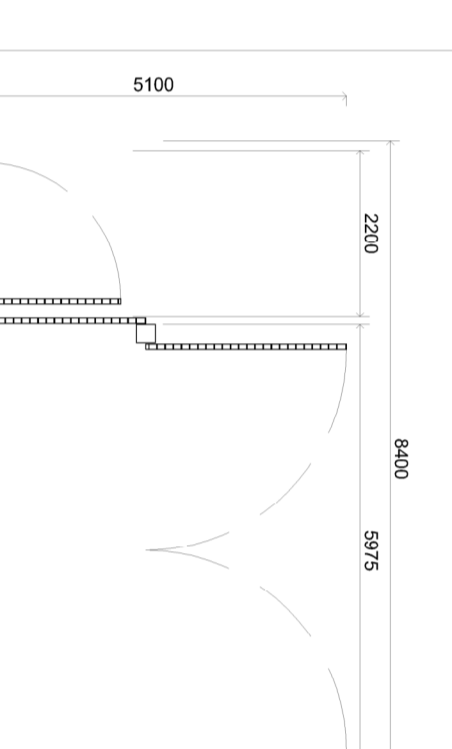

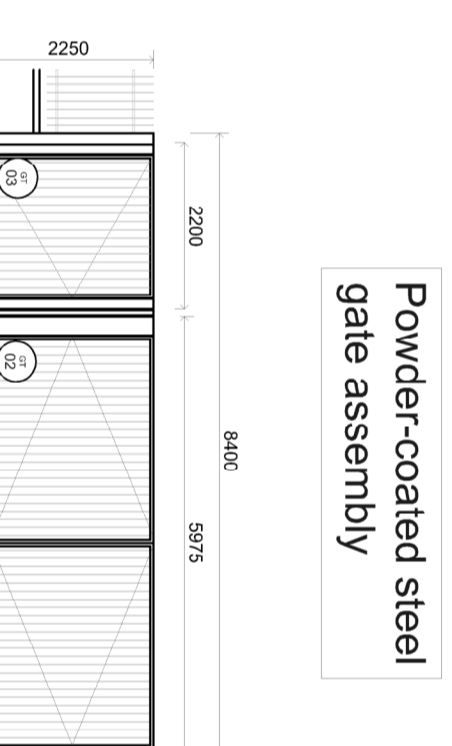

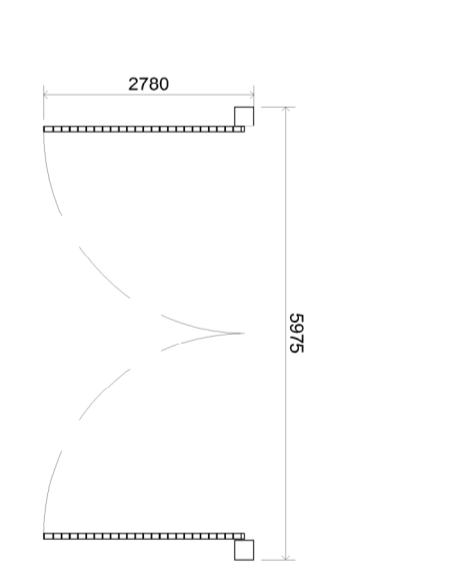

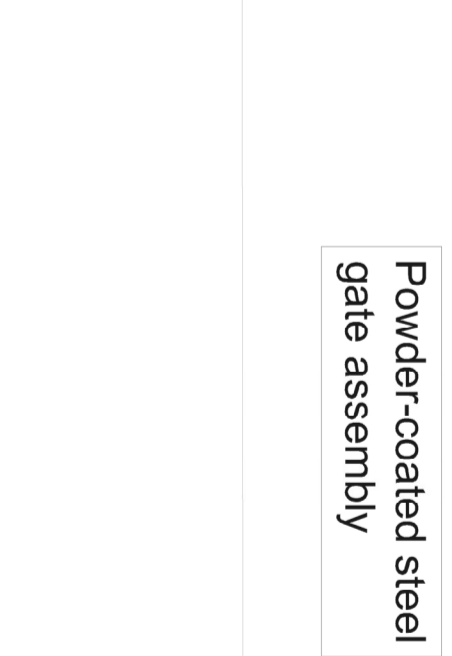

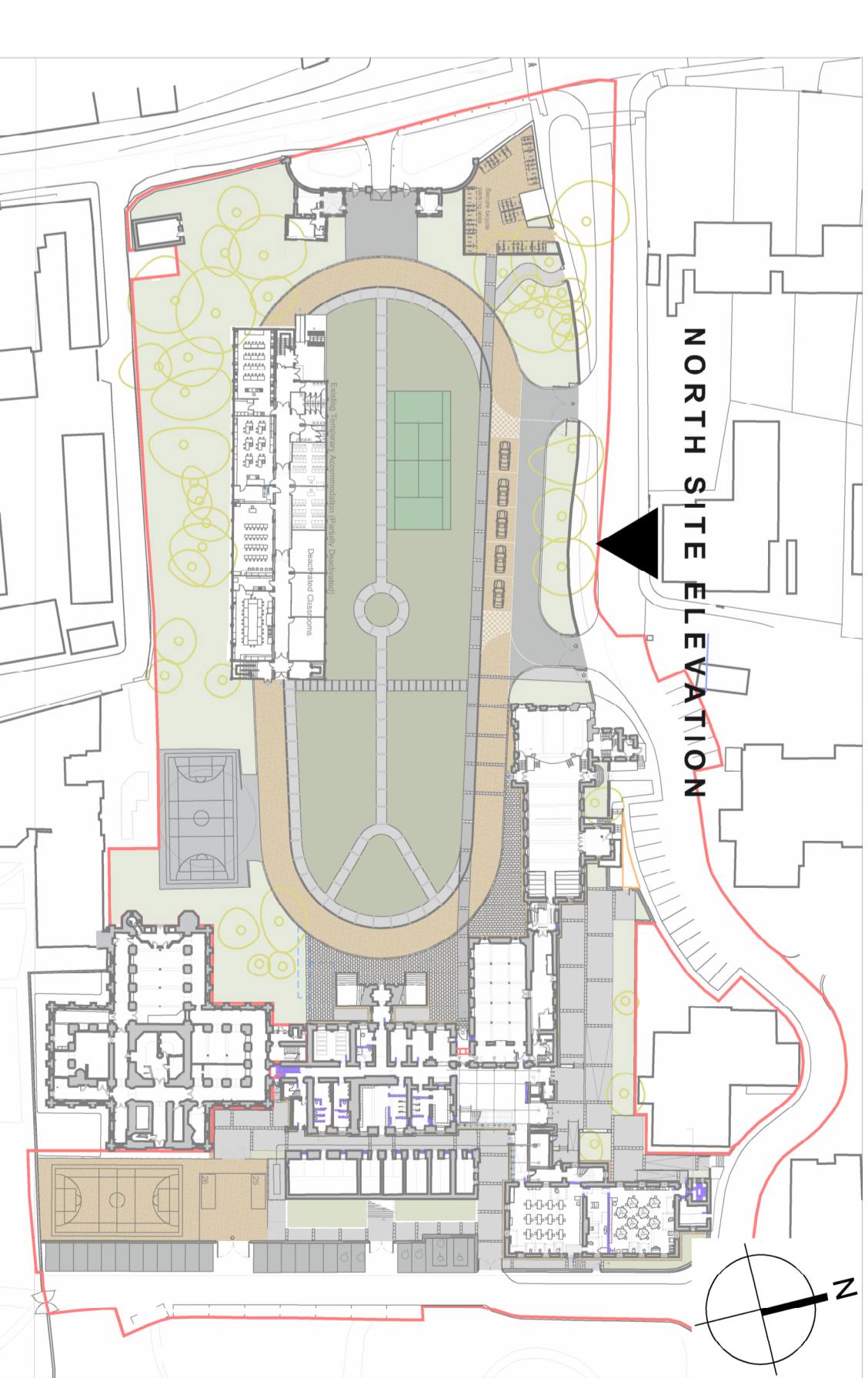
