We wish to submit an **Objection** to the erection of the Telecommunications support structure, antennae, dishes, and associated equipment at **Esker House**.

(1) Dept. of the Environment Guidelines for planning Authorities ,Section 4 paragraph 4.3 states **proximity to listed buildings , archaeological sites, and monuments should be avoided**, The proposed development is located within the curtilage of a **Protected Structure Esker House**.

(2) The proposed mast would be in **Close Proximity** to a **Pre- School** that exists **within the grounds of Esker House**. While there is no definitive proof that these masts are harmful to health there is a growing body of international research recommending a" **Precautionary**" approach to the erection of masts near schools.

(3) **Visual Impact**, The Mast will only be **Partially** screened by trees **when in full foliage**. The mast will be **Visible** above the **tree line** and will impact the green space and established walkways.
