Visual Impact :-

This is a historic area and thus this tower will be obviously out of place in this picturesque part of Lucan. Could it not be installed along a motorway away from residential areas? Planning permission can be hard to get for a dwelling house extension, how can something of this size get approved when so many people oppose it.

Devalue peoples' property in the area:-

An installed mast would adversely affect the value of peoples' houses and their saleability in the future. It would be situated in close proximity to residential dwelling houses. No consideration was taken when it comes to the residents living near to the tower.

An installed mast, is accepted precedence for future masts in the area and future technological developments such as 6g which is already in the pipeline.

Hightspeed fibre broadband available already:-

There doesn't seem to be an issue with phone coverage in the local area and high speed fibre broadband is available and it is not confirmed if this mast is to benefit the local area or further beyond.

Health affect of 5g and future technologies that may be installed:-

As 5g is relatively new, the World Health organisation has not yet published a report on its long term health affects to people living in close proximity to these telecommunications masts. There are young families living in the area, young kids are most at risk as their brains are developing. There are

pre schools, primary and secondary schools in the area and a retirement home situated very to the proposed location. All these people are being put at unknown risk in order to make profits for the telecommunications company. People are being used as guinea pigs without them knowing until it is too late.
