REQUEST FOR EXTENSION TO FURTHER INFORMATION RESPONSE PERIOD IN RESPECT OF PROPOSED MIXED-USE DEVELOPMENT COMPRISING APARTMENTS, OFFICE FLOORSPACE, 4 NO. RETAIL UNITS, A CRECHE AND URBAN SQUARE IN THE CLONBURRIS DEVELOPMENT AREAS CUC-S3 & CSW-S3 OF THE CLONBURRIS SDZ PLANNING SCHEME 2019.

On behalf of the applicant, Cairn Homes Properties Limited 45 Mespil Road, Dublin 4 we hereby request a time extension from South Dublin County Council to the request for further information, dated the 17th of February 2023, in respect of the above proposed development.
