We wish to object to the proposed development on the grounds as follows:-


Our home is located on the boundary of the grounds, located at the lower end of the hill. All water from the grounds drains to our property. We have a well water supply which is quite shallow due to the water table in the area. We have major concerns about the proposed Astro turf pitch due to the water run-off to our property from the fields which could result in toxins from the artificial pitch entering our drinking supply.

The lane is a single track in places with cars trying to pass each other where there is no room, this leads to erosion of the soft verges and collapsing of ditches into the water channel, making it impossible for surface water to run off and resulting in flooding at our entrance on a regular basis. Despite taking remedial action over the years this is a problem that is still present to this day.

The inevitable bottle necks that occur on a regular basis lead to horn blowing, arguments and verbal abuse on a weekly basis. The previous planning was supposed to allow for a time delay between events to allow traffic to leave before the next band of traffic arrives, this has not been kept to, leading to the problems mentioned.

In the road safety guidelines for sporting organisations there are a number of points that cannot be met at this location, some very critical ones, that if not properly addressed could lead to a serious incident. The nature of the road makes it unsafe, there are no proper paths for pedestrians, no street lighting and no verges. It is only a matter of time before someone is hurt or worse on this lane. The volume of traffic as it is unsustainable and any allowance for an increase will be down right dangerous.

The old entrance gate has not been secured allowing access for random groups to go into the field with anti-social behaviour ensuing. As the field is land locked behind houses it is hidden from view and affects our quality of life.

Air pollution, as we are surrounded by two car parks and standing traffic in the lane, airborne pollutants from this traffic has a detrimental effect on lung health, particularly as one occupant at this address relies on medical oxygen 24/7/365.

On 9<sup>th</sup> September 2023, only 2 weeks ago, following a horrendous day on the lane with traffic, we were subjected to loud music from the club house all evening followed by anti social behaviour on the lane with screaming and shouting until approx. 2.30am. There is absolutely no consideration to residents in the area.

We ask that you give these points your deliberation in considering this application.
