I wish to object to the proposed development under this application.



Their home is serviced by a shallow natural well which provides all water to the home, including drinking water.

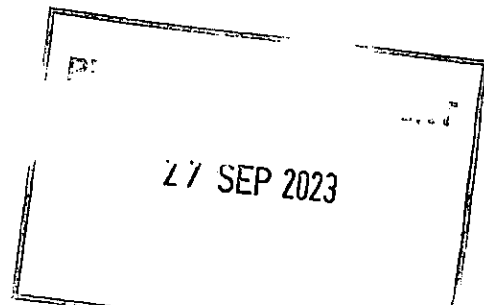
My concern relates to the known hazards of artificial pitch products and relationship to cancer cases. The issues with artificial turf are well documented at EU and international levels and real cause for concern.
