Dear Liam and to whom it may concern,

For the purposes of the planning application process as referenced above and in my capacity as AirNav Ireland Air Navigation Service Provider (ANSP) Manager Airspace and Navigation, I have reviewed all documentation supplied by you in relation to this development, including:

- Glint & Glare Assessment and Appendices
- Contractor Construction Management Plan
- Contractor Crane Plan
- Crane Elevation
- Crane Specifications

These details have in turn been copied to the Irish Air Corps, as this development will need to be assessed by them in relation to Baldonnell Aerodrome surfaces.

From an AirNav Ireland perspective, there are no issues in relation to the Instrument Flight Procedures at Dublin Airport.

I can therefore confirm that:

- The proposed construction works - inclusive of cranes - will not affect the safety, efficiency or regularity of aircraft generally operating to or from Dublin Airport or controlled by Dublin Air Traffic Control Centre
- The proposed development - inclusive of the solar panels - will not affect the safety, efficiency or regularity of aviation operations or the emergency services operated in the vicinity of Tallaght Hospital
