In relation to the provision of EV Parking it will the intention of this development to align with Part L of the building regulations which requires

'A building which has more than 10 car parking spaces that is new shall have installed at least one recharging point and ducting infrastructure (consisting of conduits for electric cables) for at least one in every 5 car parking spaces to enable to subsequent installation of recharging points for electrical vehicles'



Our proposal is to supply 2 no. charging points and ducting for a further 3 spaces as detailed in the attached site plans, which exceeds the requirement of Part L. We trust this will be adequate for the nature of this development.
