

SWIFTBANKS

Swiftbanks is the proposed name for the development at Mill Road, Saggart. The development name has been inspired by the historic Swiftbrook Paper Mills (approximately 325m southeast).



Established during the 18th century, Swiftbrook Paper Mills were not just an establishment, but a cornerstone of the community in Saggart. The name 'Swiftbrook' is a harmonious blend of history and geography. It's derived from the famous author and dean of St Patrick's Cathedral, Jonathan Swift (1666-1745). Combine that with the stream or brook running from Brittas through Saggart into lands owned by St Patrick's Cathedral, and the moniker Swiftbrook emerges. In naming the development the same methodology of 'blending' a name has been applied.

Here we have used the 'Swift' inspired by the Swiftbrook Paper Mills and 'Banks' refers to the Camac River which runs through the northwestern corner of the site.
