## RE: CONDITION 31 – DEVELOPMENT OF 569 DWELLINGS AT CLONBURRIS SOUTH WEST DEVELOPMENT AREA WITHIN THE CLONBURRIS SDZ AT TOWNLANDS OF CAPPAGH, CLONBURRIS LITTLE AND KISHOGE, CO. DUBLIN. REG REF: SDZ21A/0022

I write on behalf of Cairn Homes Properties Ltd in respect of Reg Ref: SDZ21A/0022 and condition 31 relating to the approved Street Naming and Dwelling Numbering for the permitted development site. The Planning Authority approved the naming and numbering scheme by letter of compliance dated 9<sup>th</sup> February 2023. The Irish translation was subsequently revised and confirmed by letter of compliance dated 29<sup>th</sup> August 2023. Please find enclosed a copy of both letters of compliance for ease of reference.

The permitted development under Reg Ref: SDZ21A/0022 was subsequently amended under Reg Ref: SDZ23A/0029. The permitted amendment under Reg Ref: SDZ23A/0029 provides for an additional 2 no. apartments in Block 1A. As a result, the numbering sequence of Block 1A has been revised as follows:
