For the convenience of the Planning Authority, this compliance submission sets out below the text of Condition 24 followed by the Applicant's compliance response.

#### **CONDITION 24 – ARCHAEOLOGICAL MONITORING**

24. The applicant/developer shall employ a qualified Archaeologist, licensed to carry out Archaeological Monitoring of all sub-surface works carried out within the proposed development site. This will include the archaeological monitoring of the removal of topsoil, the excavation of trenches for foundations, services, access roadway, etc. associated with the proposed development.

REASON: To facilitate the recording and protection of any items of archaeological significance that the site may possess.
