COMPLIANCE - PLANNING REG REF. SDZ22A/0005- CONDITION 20 – AVIATION

For the convenience of the Planning Authority, this compliance submission sets out below the text of Condition 20 of SDZ22A/0005 followed by the Applicant's compliance response.

CONDITION 20 – AVIATION

- (a) Prior to the commencement of development, the applicant shall notify the Irish Aviation Authority and the Department of Defence regarding any cranes likely to penetrate ICAO surfaces.
- (b) Prior to the commencement of development, the applicant shall submit detail of appropriate Marking and / or Lighting, as agreed with Weston Airport, for the written agreement of the Planning Authority.

REASON: In the interests of aviation safety.

Applicant's Response:

- (i) Part (a) of this Condition is noted.
- (ii) We refer to the enclosed Site Location Map Drawing and the Adamstown ACD Crane Layouts Model prepared by Henry J. Lyons Architects showing details and locations of the cranes. Crane details are found in the document prepared by Kobelco including details on the height of the cranes.
