For the convenience of the Planning Authority, this compliance submission sets out below the text of Condition 15(b) followed by the Applicant's compliance response.

CONDITION 15: DRAINAGE

- a) There shall be complete separation of the foul and surface water drainage systems, both in respect of installation and use.
- b) All works for this development shall comply with the requirements of the Greater Dublin Regional Code of Practice for Drainage Works.

REASON: In the interest of public health, the proper planning and sustainable development of the area and in order to ensure adequate water supply and drainage provision.

Applicant's Response:
